SUMMARY STATEMENT:

On February 22, 2024, staff publicly advertised a Request for Qualifications (RFQ) KT 24-885 for the SR 104 & Bond Road Park and Ride Design project. Staff received two (2) proposals and PACE Engineers scored highest based on evaluation criteria. Staff completed a cost analysis and negotiations for the scope of work and considers PACE Engineers' cost proposal to be fair and reasonable in the amount of six hundred seventy-one thousand seven hundred twenty dollars and ninety-eight cents (\$671,720.98).

MOTION: Move to adopt Resolution No. 24-31, authorizing staff to contract with PACE Engineers for the SR 104 & Bond Road Park and Ride Design project, in the amount of six hundred seventy-one thousand seven hundred twenty dollars and ninety-eight cents (\$671,720.98).

A RESOLUTION OF KITSAP TRANSIT BOARD OF COMMISSIONERS AUTHORIZING STAFF TO AWARD A CONTRACT TO PACE ENGINEERS FOR THE SR 104 & BOND ROAD PARK AND RIDE DESIGN PROJECT

WHEREAS, on February 22, 2024, Kitsap Transit procurement staff publicly advertised a Request for Qualifications (RFQ) KT 24-885 for the SR 104 & Bond Road Park and Ride Design project; and

WHEREAS, this project will complete the required design and environmental analysis for National Environmental Policy Act (NEPA) and Right-of-Way Acquisition; and

WHEREAS, on March 7, 2024, staff received and evaluated qualifications and proposals from two (2) firms and PACE Engineers scored highest based on the proposal and evaluation criteria; and

WHEREAS, PACE Engineers has submitted a proposal for the SR 104 & Bond Road Park and Ride Design project for an amount of six hundred seventy-one thousand seven hundred twenty dollars and ninety-eight cents (\$671,720.98); and

WHEREAS, staff has completed a cost analysis and negotiations for the scope of work and considers PACE Engineers' cost proposal to be fair and reasonable; and

WHEREAS, this project was included in the 2024 Capital Budget – Transit Fund for the SR 104 & Bond Road Park and Ride Design project; and

WHEREAS, this proposal is seventy-one thousand seven hundred twenty dollars and ninety-eight cents (\$71,720.98) over the approved budget; and

WHEREAS, staff has reviewed the cost proposal budget overage and has deemed it fair and reasonable based on the market rate inflation since the 2024 budget was approved; and

WHEREAS, staff recommends award of the SR 104 & Bond Park and Ride Design project to PACE Engineers.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners hereby authorizes staff to award a contract to PACE Engineers for design of the SR 104 & Bond Road Park and Ride in the amount of six hundred seventy-one thousand seven hundred twenty dollars and ninety-eight cents (\$671,720.98).

On February 22nd, Procurement Staff released a Request for Qualifications; KT 24-885 SR 104 & Bond Road Park and Ride Design Project. On March 7th, Kitsap Transit received two (2) proposals in response to their request. Both proposals were deemed responsive and forwarded to the Evaluation Committee for review.

Kitsap Transit's Evaluation Committee evaluated the proposals based on Project Approach and Methodology, Technical Capacity, Past Experience, and Key Personnel; as described in the solicitation. When the evaluations were complete, Procurement tabulated the scores. Pace was scored as the "most highly qualified" firm.

In accordance with the "Brooks Act", staff requested a Cost Proposal from Pace. Staff conducted negotiations on cost and scope to arrive at a "fair and reasonable" cost of \$671,720.98.

Recommendation

Procurement Staff has completed the responsiveness and responsibility checks and has deemed Pace responsive and responsible. It is my recommendation that Pace be awarded the KT 24-885 SR 104 & Bond Road Park and Ride Design project.

SUMMARY STATEMENT:

This resolution authorizes staff to enter into a contract with IO Currents to purchase equipment for each of Kitsap Transit's (KT) 10 vessels and a subscription for three (3) years of vessel monitoring services. This contract allows KT to provide fleet-wide machinery/equipment monitoring, reporting, and software services that will allow KT to predict maintenance needs and schedules.

The equipment included in this bid totals one hundred thousand dollars (\$100,000) and is included in the 2024 Capital Budget. The total subscription cost totals one hundred sixty-seven thousand four hundred dollars (\$167,400) and is included in the 2024 Ferry Operating Budget approved via Resolution 23-68, on November 07, 2023. The total proposed expenditure is two hundred sixty-seven thousand four hundred dollars (\$267,400).

A RESOLUTION OF KITSAP TRANSIT BOARD OF COMMISSIONERS AUTHORIZING KITSAP TRANSIT STAFF TO AWARD CONTRACT KT 24-901 VESSEL MONITORING SERVICES TO IO CURRENTS

WHEREAS, On April 19th, 2024, Procurement Staff released a Request for Proposals; KT 24-901 Vessel Monitoring Services; and

WHEREAS, this contract will provide fleet-wide machinery/equipment monitoring, reporting, and software service that will allow Kitsap Transit (KT) to view equipment and allow for trend analysis and better predict maintenance schedules; and

WHEREAS, On May 8th, 2024, KT received four (4) bids in response to the solicitation; and

WHEREAS, IO Currents was the apparent highest scored bidder pending responsiveness and responsibility checks in the estimated amount of two hundred sixty-seven thousand four hundred dollars (\$267,400); and

WHEREAS, staff completed a responsive and responsibility check and has deemed IO Currents bid responsive and responsible; and

WHEREAS, staff has determined the bid pricing received from IO Currents to be fair and reasonable; and

WHEREAS, the equipment included in this bid totals one hundred thousand dollars (\$100,000) and is included in the 2024 Capital Budget approved via Resolution 23-68 on November 07, 2023; and

WHEREAS, the subscription service is fifty-five thousand eight hundred dollars (\$55,800) a year for a contract period of three (3) years bringing the total subscription cost for three (3) years to one hundred sixty-seven thousand four hundred dollars (\$167,400); and

WHEREAS, the cost for the first year in the amount of fifty-five thousand eight hundred dollars (\$55,800) is included in the 2024 Ferry Operating Budget approved via Resolution 23-68 on November 07, 2023.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners hereby authorizes staff to award contract KT 24-901 to IO Currents for Vessel Monitoring Services in the amount of two hundred sixty-seven thousand four hundred dollars (\$267,400).
