

## **DETERMINATION OF NONSIGNIFICANCE**

Project Description: Kitsap Transit proposes to construct a new eight-bay bus transit center and 166 stall park and ride on a 4.14 acre site immediately adjacent to Wheaton Way (SR 303). The transit center, to be owned and operated by Kitsap Transit, will replace the existing transit station on a privately-owned lot at Sylvan Way, south of the new location. Proposed improvements include a bus driver comfort station, community one-room police office, bus shelters, plaza areas, sidewalks, bike racks, parking, and car charging stations. Stormwater conveyance, detention and water quality treatment are proposed for the site. The project does not contain a creek or wetland and discharges into a closed stormwater conveyance system. The drainage regulations used for this project are based on the standards and requirements found in the 2014 Washington State Department of Ecology Stormwater Management Manual for Western Washington (SWMMWW) and the 2012 Low Impact Development Technical Guidance Manual for Puget Sound (LID Manual). The City of Bremerton Municipal Code (BMC) will also be used as regulatory manuals for the stormwater elements of this project.

**Project Location:** The proposed project is located in the city of Bremerton, Kitsap County, Washington, and falls within Section 2, Township 24 N, Range 1 E of the Willamette Meridian. The project site is located on the southwest corner of the intersection of Wheaton Way (SR 303) and E Broad Street. The physical address of the site is 3915 Wheaton Way, Bremerton, WA 98310.
